2022 HJ Templin Preseason Cup Competition Rules

Registration for the HJ Templin Preseason Cup

Players, coaches and all team officials who will be part of the seniors' fixtures will need to be registered on PlayFootball. They will need to register under their Club name and select the relevant HJ Templin Cup Registration Option. There will no charge for the Players to register for the HJ Templin Cup.

This registration will only be for this pre-season competition at the conclusion of the HJ Templin Cup this registration will end, and registrations will then need to be completed to participate in Season 2022.

1. The HJ Templin Pre-season Cup Competition, the structure and participating Clubs will be determined by the Competition Manager in association with, and at the sole discretion of the SAASL Management Committee.
2. Only applications received by the due date will be considered by the Competition Manager.
3. Games will be played with two 45 minute halves with a 2 minute break at about the 20 minute mark of each half if required due to heat. Kick off times will be as shown on the weekly fixture list & may be subject to change, however any changes will be advised accordingly by the Competition Manager.
4. **All participating clubs will play a minimum of 5 rounds and are not permitted to schedule other pre-season games during the HJ Templin Cup without prior approval.**
5. For the Senior matches, team sheets must be completed via Sports TG. Team sheets for the Reserves friendlies, will need to be completed manually (blank copy will be provided by SAASL). All team sheets to be completed prior to kick off & handed to the referee. No more than 17 players per team to be written on team sheet. Substitutions will be from the halfway line with the approval of the referee on an interchange basis. There is no limit to the number of substitutions.
6. The winners of each of the four groups will play in a Semi Final (Semi Final 1 – 1st Group 1 vs 1st Group 2 and Semi Final 2 – 1st Group 3 vs 1st Group 4) all other teams will play a team from another group. The winner of Semi Final 1 & 2 will go onto compete in the HJ Templin Cup Grand Final.
 - a. The HJ Templin Grand Final game will be played in late March prior to the commencement of the League Season at a venue & date to be determined by SAASL with preference of weeknight games at a SAASL club venue that will provide the necessary atmosphere & facilities to showcase the event
 - b. The HJ Templin Pre-Season Cup Medal will be presented to the player as judged by the referee to be best on ground in the Cup Grand Final.
7. There will be no extra time played or penalty shootout for any group games from round 1-5 the result will stand at the end of normal time. In the event that scores are level after full time during the HJ Templin Cup Semi Finals & Grand Final a penalty shootout will take place (there will be no extra time).

- a. The match result will be determined by taking “penalty kicks”. Penalty kicks in sets of five shall be taken. If still a draw, single penalty kicks shall be taken until such time that a decision is reached. The kicks shall be taken in turn by the two teams and by different players. Note: No player can take a second kick until such time that all players in the team have had their turn.
8. Participating clubs must also SMS text to the Competition Manager (0411 858 488) all results & their team goal scorers at the completion of each game.
9. **All team sheets to be emailed to results@saasl.com.au and the original to be sent to SAASL, Freepost, PO Box 82, Findon SA 5023 to arrive by Wednesday after each game.**
10. Fees for Match Officials in HJ Templin Cup Group Games & Semi Finals will be shared on a 50/50 basis with each participating club to be invoiced by the League. Match official Fees for the Grand Final will be borne by SAASL.
11. The current SAASL Disciplinary Rules for Players and Clubs will apply. However, the accumulation of yellow cards will be cleared at the end of the Templin Cup Series. Players will only be suspended within the Templin Cup competition on receiving 5 cautions (one match). This will not carry over into League Season 2022.
12. For any serious breaches of the Rules and Regulations, any Players, Coaches or Clubs may be sanctioned under the Disciplinary Rules, and at the discretion of the Disciplinary Committee, any sanction or penalty may be determined to carry over into the Season 2022.
13. Notwithstanding the above, the SAASL Competition Rules and Regulations, including SAASL Codes of Conduct for players, club officials & spectators will apply.
14. Players must have played in at least one match prior to the Cup Semi Final to be eligible to play in the Cup Final Series of the HJ Templin Preseason Cup.
15. For players to be eligible for the Player Insurance during the HJ Templin Cup, Clubs will be advised prior to the Pre-season Competition Commencing.
16. The SAASL, Competition Manager and Referees decisions will be final. Any breach of the SAASL Codes of Conduct towards Referees or linesman by players, Club officials or spectators will NOT be tolerated. All concerns must be only addressed directly to the Competition Manager.
